## Reopening .MX Policies

This document is an integral part of the Lineaments .MX and will be applicable during the Reopening Process of registration of Domain Names directly under .MX in what is related to the application, registration and management of the referred Domain Names; it is important to state that this document only establishes the modifications of the Domain Names General Policies of the Registry .MX during the Reopening Process; nevertheless the Domain Names General Policies of the Registry .MX will still be applicable at all times, exception made to the modifications set up in this document.

### 1. Definitions.

#### 1.1. Origin Domain Name.

Domain Name under any of the following categories: .com.mx, .org.mx, .edu.mx, .net.mx, that grants the Registrant the ability of applying the registry of a Domain Name directly under .MX.

#### 1.2. Reopening Process.

Period of time during which is started the application and registration of Domain Names directly under .MX. The same is divided in three stages: Sunrise period, Quiet period and Landrush period. These periods will have specific terms and characteristics that can be modified by the Registry .MX, prior to the notice sent to the Registrars via e-mail.

#### 1.3. Reserved Domain Names.

Domain Names directly under .MX that are not able to be registered.

The terms referred in capital letters and without definition in this document will have the definition and meaning that was given in the Domain Names General Policies of the Registry .MX, unless that in this document were to be defined otherwise or such definition or sense were to be limited.

The terms defined in this document as in the Domain Names General Policies of Registry .MX can be used in the current document either in singular or plural sense.

All the headlines used in this document are used exclusively to facilitate the lecture of the same and should not be part of the interpretation of the same.

### 2. About the Domain Names directly under .MX already existing (with date of registration prior to May 1<sup>st</sup>, 2009).



The Domain Names directly under .MX already existing before May 1<sup>st</sup>, 2009 cannot be eliminated or cannot apply to be transferred during the Reopening Process.

**3. Domain Names with pending application.**

During the Reopening Process, the Registrar cannot modify or submit an application to transfer an Origin Domain Name from which an application of registration of a Domain Name directly under .MX is filed, and that such application has a pending status.

**4. About the use of a Domain Name directly under .MX**

By the assignation of the Domain Name directly under .MX made by the Registry .MX during the Sunrise and Quiet periods the right of the holder (Registrant) to use the Domain Name directly under .MX is recognized until the start of the Landrush period for the term of coverage paid.

**5. Initial coverage term.**

The maximum term of coverage of Domain Names directly under .MX registered during the Reopening Process is of one year.

**6. Additional requirements to register.**

Some categories of Domain Names may have additional requirements for their registration, according with Annex A and to the published communications of the Registry .MX.

**7. Additional classifications.**

During the Reopening Process the Registry .MX will accept also applications to register Domain Names directly under .MX.

**8. About renovation.**

The Domain Names directly under .MX registered cannot be renovated during the Sunrise and Quiet periods.

**9. Dispute and Complaint of a Domain Name.**

The Registrar will be responsible to process and give solution to the problems that may arise regarding the Domain Names that it manages, exception made to the complaints from the application and registration of Domain Names directly under .MX, procedure that will be managed directly by the Registry .MX, according with the corresponding document that the Registry .MX will publish in its website ([www.registry.mx](http://www.registry.mx)).
